#### **Summary:**

The numbers of learners around the globe are steadily rising due to demographic reasons and the reduction of poverty. Providing all these learners with quality education is an enormous challenge. Many aspects need to be addressed, ranging from teacher training and safe environments to adapting curricula and ensuring fair assessment. Learners need to be prepared for life as local and global citizens, with due respect for their diverse capacities and diverse cultures.

All this needs to be embedded in good governance, human dignity and effective policies. The right to education and rights in education are essential in dealing with student and school diversity, but expertise on these fundamental concepts is relatively rare and scattered. In 2015, a group of concerned individuals, active in education, research and public administration, decided to join forces and provide a concerted helping hand to all those who want to formulate and implement sound education principles, policies, codes, rules and regulations.

The initiators have decided to set up the Global Education Law Forum (GELF) as a non-profit consortium that will address these issues both from a practical and a scholarly perspective.

GELF will thus contribute to the implementation of the newly adopted UN Sustainable Development Goal number 4: 'Ensure inclusive and quality education for all and promote lifelong learning' and the UNESCO Education 2030 Framework for Action.
